BOARD NOTICE 185 OF 2021
SOUTH AFRICAN PHARMACY COUNCIL

FEES PAYABLE TO THE COUNCIL UNDER THE PHARMACY ACT, 53 OF 1974

In terms of Section 4(zG) of the Pharmacy Act, 53 of 1974, read together with Regulation 106 of the *Regulations relating to the registration of persons and the maintenance of registers* (GNR. 1160, published on 20 November 2000), Council may determine the fees payable to Council. This means that any new fees or amendments to existing fees are determined annually by Council. As in the past, all efforts will be made to curtail costs and keep any increases in fees to a minimum. The fees for the year 2022 are published below for general information:
