Big data analytics, which leverages comprehensive datasets to manage population health will also form part of the informative discussions.

The congress will provide Continuing Professional Development (CPD) opportunities through a dynamic schedule of keynote addresses, panel discussions, and interactive sessions, all designed to help delegates remain abreast with the latest advancements and best practices in the pharmaceutical industry.
